State Name : Kerala

Road Permit/E-way Bill : E-Declaration

Remarks : Vehicles are getting cleared with E-declaration generated from Kerala GST site.

State Name : Maharashtra

Road Permit/E-way Bill : No Road permit till further notice by state

Remarks : No Octroi, No N Form, No R Form

State Name : Madhya Pradesh

Road Permit/E-way Bill : GST Invoice and AWB is required

Remarks : Only GST Invoice and AWB is required

State Name : Orissa

Road Permit/E-way Bill : No Road permit till further notice by state

Remarks : Notification dated 30th of Orissa local language stating shipment can move with GST Invoice Only. Communication has been issued by the authorities that requirement of waybills shall be postponed for 2 months.

Road Permit/E-way Bill : No Road permit till further notice by state

Remarks : Notification dated 30th stating Shipments can move with GST invoice and Transport document (Dopcket & consignment note)

Remarks : E-way Bill discontinued in Uttar Pradesh vide Circular No.1718015 dated 30 June 2017 till implementation of eway bill rules under GST Bilty and

Remarks : Communication has been issued by the authorities that the Govt us working to design an alternative model like "Inward Permit" till E-way bill is introduced. Considering the finalization of the new procedure of the 'Inward Permit' may take 5 to 7 days, communication also mentions the guidelines to be followed for movement of goods in the interim periof which requires goods to move along with invoice copy, consignment note etc.
